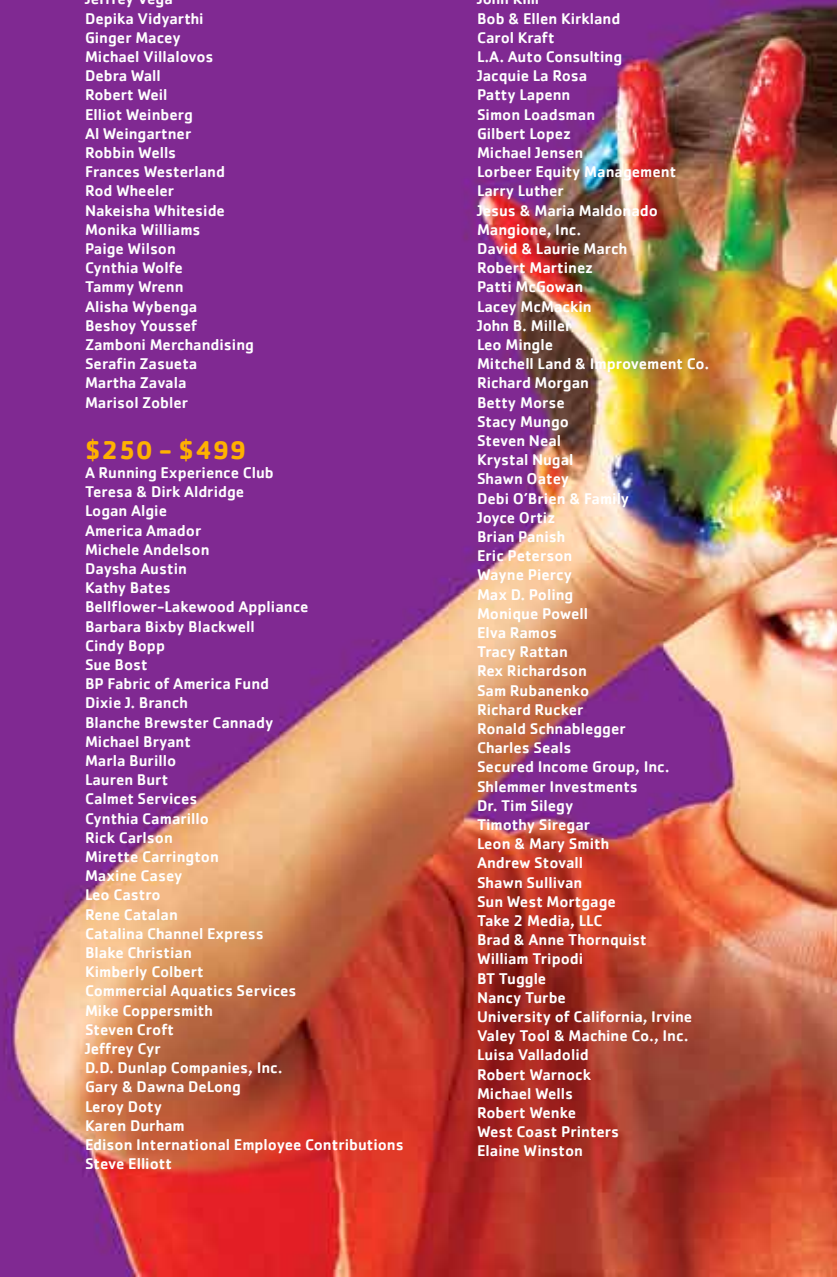

Giving back and providing support to our neighbors.

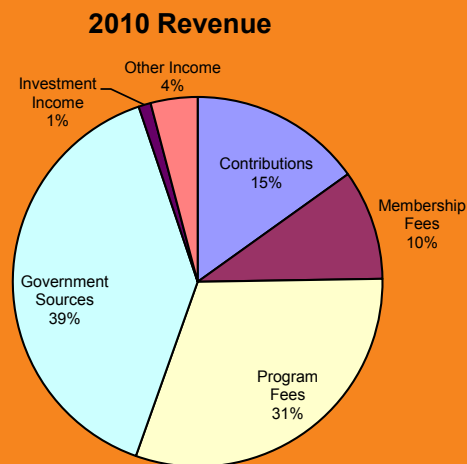

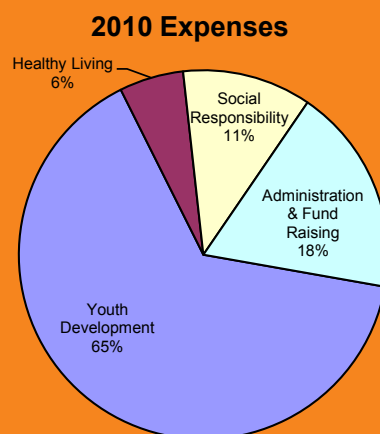
